Generally, includes Burnt Store Marina, Northeast Cape Coral, North Fort Myers, and from there along the East along northern edge of the Caloosahatchee River to N. Olga Road and north to the Charlotte County line

The northern edge of Lee County from Burnt Store Marina west to Trout Creek (just west of Highway 31).

Northwest corner of Burnt Store Marina along the coast, south to Caloosa Road.

East on Caloosa Road to Burnt Store Road.

South on Burnt Store Road to Jacaranda Parkway W.

East on Jacaranda Parkway to Chiquita Boulevard.

South on Chiquita Boulevard to Wilmington Parkway.

Northeast on Wilmington Parkway to Santa Barbara Boulevard.

South on Santa Barbara Boulevard to SE 15th Terrace.

East on SE 15th Terrace to SE 1st Place.

North on SE 1st Place to SE 13th Terrace

East on SE 13th Terrace then south on SE 5th Court

North along San Carlos Canal to then East on SE 13th Street to Academy Boulevard.

North on Academy Boulevard to Nicholas Parkway.

East on Nicholas Parkway and north Country Club Boulevard to SE 12th Street

Northwest on SE 11th Street (on some maps this is labeled as 12th St) to SE 9th Place.

Northeast on SE 9th Place to SE 10th Street

Southeast on SE 10th Street to Country Club Boulevard

Northeast on Country Club Boulevard to SE 9th Lane

Northwest on SE 9th Lane to SE 9th Street.

East on SE 9th Street, merging with Viscaya Boulevard to Del Prado Boulevard

South on Del Prado Boulevard to Coral Point Drive

East on Coral Point Drive to SE 16th Place.

North on SE 16th Place to SE 16th Street,

East on SE 16th Street to SE 20th Court

North on SE 29th Court, east on SE 15th Street to the Chantrey Canal

North along the Chantrey Canal to Viscaya Parkway

East on Viscaya Parkway to SE 21st Avenue

South on SE 21st Avenue to SE 10th Terrace

East on SE 10th Terrace to SE 23rd Avenue

South on SE 23rd Avenue to SE 13th Street

East on SE 13th Street to SE 23rd Place

South on SE 23rd Place to SE 15th Street

East on SE 15th Street to SE 24th Avenue to the Chantrey Canal

North on Right-of-Way between SE24th Avenue and Inverness Circle to St Clair Avenue

East on St Clair Avenue to the St Lawrence Canal

South along the Sat Lawrence Canal to the Caloosahatchee River.

East along the Caloosahatchee River to N. Olga Road.

North on N. Olga Road to N. River Road.

North and west to Armeda Road.

North on Armeda Road to Trout Creek

North along Trout Creek to the Charlotte County Line.
